**Background:**

USAID-Ethiopia’s Agricultural Growth Program-Livestock Market Development project is a five-year project being implemented as part of the U.S. Government’s feed the Future (FTF) Initiative. This project is USAID’s contribution to the Government of Ethiopia’s Agricultural Growth Program (AGP). The AGP’s goal “to end poverty and enhance growth” aligns with FTF’s goal to “sustainably reduce poverty and hunger.” The Project aims to foster growth and reduce poverty through improving the productivity and competitiveness of selected livestock value chains in AGP-targeted areas. As part of project activities, the AGP-LMD Project purchased 100 units of 2000liter and will grant to different milk collection centers to help mitigate inefficiencies in Ethiopia’s dairy sector and build capacity for Ethiopian dairy production.

**Purpose**

The purpose of this RFQ is to solicit quotation from eligible transport service providers ,to transport 86-100 units of milk chilling tanks from the project warehouses to different milk chilling centers, which are found in five regions , Addis Ababa, Oromia, Tigray, Amhara and SNNP (as listed in Appendix B: List of the project’s warehouse locations, location of chilling centers, etc.)

**2. QUESTIONS/CLARIFICATIONS**

All questions and/or clarifications regarding this RFQ must be in writing and can be submitted to [afiseha@livestockmarketdevelopment.com](mailto:afiseha@livestockmarketdevelopment.com) Questions and requests for clarification must be received by email no later than 15:00, Addis Ababa, East Africa Time Zone, on 25 August 2017. Questions must be submitted in writing; phone calls will not be accepted. Questions and requests for clarification—and the responses thereto—that CNFA believes may be of interest to other offerors will be circulated to all RFQ recipients who have indicated an interest in bidding.

Only the written answers issued by CNFA will be considered official and carry weight in the RFQ process and subsequent evaluation. Any verbal information received from employees of CNFA or any other entity should not be considered as an official response to any questions regarding this RFQ.

### **3. ELIGIBILITY OF OFFERORS**

In accordance with Federal Acquisition Regulation Clause 52.209-6, "Protecting the Government's Interest When Subcontracting with Contractors Debarred, Suspended, or Proposed for Debarment," (OCT 2015), all offerors must certify that they are not debarred, suspended, or proposed for debarment by the USG. AGP-LMD will not award a subcontract to any firm or firms' principals who are debarred, suspended, or proposed for debarment, or who proposes to do business with firms (including subcontractors) or firms' principals who are debarred, suspended, or proposed for debarment, in the performance of the requirement of this activity.

### **4. QUOTATIONS**

Quotations in response to this RFQ must be priced on a fixed-price, all-inclusive basis, including delivery and all other costs. All vendors have to be offer price in ETB (in Ethiopian Birr). Offers must remain valid for not less than 60 calendar days after the offer deadline.

In addition, offerors responding to this RFQ are requested to submit the following:

- Quotations should be submitted within the same envelope or package.
- Organizations responding to this RFQ are requested to submit a copy of their official registration or business license.
- Individuals responding to this RFQ are requested to submit a copy of their identification card.
- Interested vendors should also submit the following information:
  - Bidder's full legal name, contact information, and the name of the authorized representative;
  - List of similar services performed during the last few years in Ethiopia;
  - The duration of the validity of the quotation. The duration of validity of the quotation should be no less than 60days;

### **5. TERMS AND CONDITIONS OF THE RFQ**

Issuance of this solicitation does not in any way obligate AGP-LMD to award a subcontract, nor does it commit AGP-LMD to pay for costs incurred in the preparation and submission of the offer. AGP-LMD reserves the right to make revisions to the content and order of the provisions in the actual purchase document prior to execution by AGP-LMD and the selected awardee.

Please note this solicitation is subject to the following terms and conditions:

- (a) Payment will only be issued to the entity submitting the offer in response to this RFQ and identified in the resulting award; payment will not be issued to a third party.
- (b) Any award resulting from this RFQ will be in the form of a Purchase Order for the equipment quoted by the vendor.
- (c) No services may be supplied involving any of the following countries: Burma (Myanmar), Cuba, Iran, North Korea, (North) Sudan, Syria
- (f) United States law prohibits transactions with, and the provision of resources and support to, individuals and organizations associated with terrorism. The supplier under any award resulting from this RFQ must ensure compliance with these laws.
- (h) Prices should clearly indicate, in separate lines, the basic price, and any additional taxes, including But not limited to VAT etc.

All offers should be submitted in English

### **6. BASIS FOR AWARD**

The award will be made to a responsible offeror whose offer follows the RFQ instructions, meets the eligibility requirements, and is determined via a trade-off analysis to be the best value based on application of the criteria below. A Review Panel, appointed by the AGP-LMD project, will evaluate quotations submitted by eligible firms in accordance with the following:

- **Technical – 30%:** Responsiveness to the technical specifications and requirements.
- **Total delivery period -30% :** Total number of days to transport all tanks to grantees sites
- **Past experience– 10%:** List of similar services performed during the last few years
- **Price – 30%:** The overall cost presented in the offer.

Please note that if there are significant deficiencies regarding responsiveness to the requirements of this RFQ, the offer may be deemed “non-responsive” and thereby disqualified from consideration. CNFA reserves the right to waive immaterial deficiencies at its discretion.

## 7. NEGOTIATIONS

Best-offer quotations are requested. It is anticipated that award will be made solely on the basis of these original quotations. However, CNFA reserves the right to:

- Conduct negotiations with and/or request clarifications from any offeror prior to award;
- While preference will be given to offerors who can address the full technical requirements of this RFQ, CNFA may issue a partial award or split the award among various suppliers, if in the best interest of the AGP-LMD Project;
- Cancel this RFQ at any time.

## 8. PLACE OF PERFORMANCE

The location of the project warehouses and the location of the final destination or the milk chilling centers are listed down under Appendix A

## 9. PAYMENT AND AWARD

The Purchase Orders will be awarded to the offeror whose quotation represents the best value to AGP-LMD. The payment will be made through a Purchase Order between AGP-LMD and the offeror.

Bidders are responsible for ensuring that their offers are received in accordance with the instructions stated herein. Failure to adhere to the instructions described herein may lead to a quotation’s disqualification from consideration.

The negotiated purchase order/contract is subject to AGP-LMD terms and conditions.

Please note that in submitting a quotation, the bidder understands that USAID is not a party to this RFQ. Therefore the bidder agrees that any protest hereunder must be presented — in writing with full explanations — to AGP-LMD for consideration, as USAID will not consider protests regarding procurements carried out by implementing partners. CNFA, the implementer of AGP-LMD, at its sole discretion, will make a final decision on the protest for this procurement.

## 10. **Technical Requirements**

Minimum Requirements: Bidders have to provide proof that they meet the minimum criteria set out below:

1. Loading trucks carrying capacity has to be more than 600kg (ISUZU NPR /ISUZU FSR)
2. Trucks has to have third party and Comprehensive Insurance coverage
3. Trucks are to meet all vehicle safety requirements, safety equipment and road worthiness as Stipulated by the Transport Service Regulations
4. Drivers are in compliance with the Transport Service Regulations

N.B. Bidders who do not meet the above minimum specifications will be automatically disqualified and considered non-technical compliant

## **11. Response Requirements**

Bids submitted under this call must include the following:

1. Details of Bidder
2. Technical Offer (all information listed under no. 10 (technical selection criteria))
3. Financial Offer
4. Evidence that trucks meet all vehicle safety requirements, safety equipment and road worthiness as stipulated by the Transport Service Regulations
5. Evidence that Drivers are in compliance with the aforementioned Transport Service Regulations
6. Evidence of having at least 2 years' experience in carrying out similar transport services in Addis Ababa and other regions

As part of the technical proposal, the bidding firm shall attach copies of:

- Renewed business license;
- VAT registration certificate and other legal documents;
- Certification from clients for whom a transport assignment has been carried out;

N.B. Bidders who do not submit the above documentation will be automatically disqualified and considered non-technical compliant
